Re: Acquisition of Alternegy's 40% Equity in Alternegy Tanay Wind Corporation (ATWC) and Alabat Wind Power Corporation (AWPC) by A Brown Company, Inc.'s Subsidiary, ABC Energy inc. (ABCEI)

Gentlemen:

We write further to our disclosure dated October 24, 2025 and October 28, 2025 regarding our subsidiary, ABC Energy Inc.'s ("ABC Energy") acquisition of a forty percent (40%) equity stake in each of Alternegy Tanay Wind Corporation ("ATWC") and Alabat Wind Power Corporation ("AWPC"), and advise that today, June 24, 2026, ABC Energy and ATWC and AWPC have partially implemented their Investment Agreement through the acquisition by ABC Energy of 190,714 shares in ATWC and 151,523 shares in AWPC, representing approximately ten percent (10%) of the forty percent (40%) equity stake intended to be acquired by ABC Energy in each of ATWC and AWPC.

To date, ABC Energy has paid approximately Six Hundred Million Pesos (Php600,000,000.00) covering the acquisition of the 10% equity interest in ATWC and AWPC.

The Company will make further disclosures once definitive agreements for the acquisition of the remaining 30% equity interest contemplated under the Investment Agreement are concluded.

Finally, as likewise previously disclosed, the Philippine Competition Commission has issued its clearance for the transaction on March 5, 2026.
